TERMS AND CONDITIONS

PLEASE READ THOROUGHLY

1. UNLESS OPTION #1 IS CHOSEN, WATER ON TOP OF COVER MUST BE PUMPED OFF AT TIME OF SUMMERIZATION, OR AN **ADDITIONAL CHARGE WILL BE ADDED TO THE SUMMERIZATION.**
2. WATER LEVEL OF POOL MUST BE AT THE MIDDLE OF THE SKIMMER MOUTH ON DATE OF SUMMERIZATION. A SECOND TRIP IS NOT INCLUDED IN SUMMERIZATION IF WATER LEVEL IS NOT HIGH ENOUGH TO ACTIVATE THE FILTERING SYSTEM, AND A RETURN VISIT IS NECESSARY AN ADDITIONAL SERVICE CALL WILL BE CHARGED.
3. VACUUMING OR CLEAN UP OF POOL IS NOT INCLUDED IN SUMMERIZATION.
4. YORKTOWN POOL CO., INC. WILL NOT BE RESPONSIBLE FOR LOOSE TILE, CRACKED COPING, COVER DAMAGE DUE TO ANIMALS OR VANDALISM, OR ACTS OF GOD.
5. YORKTOWN POOL CO., INC. WILL NOT BE RESPONSIBLE OR LIABLE FOR DELAYS IN CONTRACT DATE CAUSED BY SHORTAGE, WEATHER CONDITIONS, STRIKES, ACTS OF GOD OR OTHER CIRCUMSTANCES BEYOND OUR CONTROL, NOR ANY ENSUING DAMAGES CAUSED BY SAID DELAYS.
6. ANY CHEMICALS AND/OR REPLACEMENT PARTS NEEDED TO COMPLETE CONTRACT **WILL BE CHARGED AN ADDITIONAL FEE.**
7. YORKTOWN POOLS CO., INC. WILL NOT BE RESPONSIBLE FOR DAMAGES INCURRED BY OWNER'S FAILURE TO COMPLY WITH RECOGNIZED SUGGESTED PROCEDURES FOR PROTECTION OF SWIMMING POOL AND ITS EQUIPMENT THROUGHOUT THE SEASON FOR WHICH IT IS USED.
8. ALL WORK TO BE COMPLETED IN A PROFESSIONAL, WORKMANLIKE MANNER. ANY AND ALL PROBLEMS ARE TO BE REPORTED TO OUR OFFICE WITHIN 24 HOURS OF SERVICE. (717-792-3541EXT.102)
9. FUTURE SERVICES, BEYOND A TEN (10) DAY LIMIT PERTAINING TO SERVICE PROVIDED, WILL BE SUBJECT TO A MINIMUM SERVICE CHARGE.

TO SECURE A PROBLEM-FREE SUMMERIZATION MAY WE SUGGEST THE FOLLOWING EASY STEPS

1. SIGN CONTRACT AND COMPLETE TOP PORTION, CHECKING OFF ALL SERVICES DESIRED.
2. IF YOU WISH, YOU MAY SPECIFY A PARTICULAR DATE FOR PREFERRED SERVICE DATE. EXAMPLE: WED. 4-23-10. EVERY EFFORT WILL BE MADE TO ACCOMMODATE YOUR WISHES. EARLY RETURN OF THIS CONTRACT WILL HELP ASSURE THIS.
3. CHECK POOL COVER TO SEE IF IT NEEDS TO BE PUMPED OFF. IF THE COVER NEEDS PUMPED OFF, DO SO, OR CALL OUR OFFICE TO UPGRADE YOUR SERVICE PRIOR TO YOUR SERVICE DATE.
4. LIFT COVER AND ADD WATER TO POOL TO PROPER LEVEL FOR SUMMERIZATION WHICH IS MID SKIMMER. WATER LEVEL SHOULD BE HIGHER RATHER THAN LOWER. YOU CAN ALWAYS BACKWASH OR VAC TO WASTE.
5. SHOULD YOU CHOOSE TO REMOVE AND CLEAN YOUR OWN COVER, THIS CAN BE DONE UP TO THREE (3) DAYS PRIOR TO SUMMERIZATION.
6. WE CANNOT GURANTEE ANY TIME OTHER THAN FIRST JOB OF THE DAY.
